Executive Director Report by Jim Mueller February 22, 2023 Board Meeting

1) Operational Issues

<u>EH&S</u>:

- All safety orientation training has been conducted for 13 new hires 10 in Distribution, and three
 (3) in Maintenance, as well as four (4) laboratory interns.
- SOPs are under development for O&M of diesel underground storage tanks in Clifton, regulatory permitting, incident reporting communications protocol and stop-work authority for PVWC staff in case of unsafe contractor working conditions.
- Ergonomic work station assessments are underway to prevent repetitive motion injuries

Pump Station:

- PVWC's contractor, Siemens, has started the second round of the inspection, testing, calibration, and maintenance of the electrical systems at the Little Falls site. Equipment tested this month includes the Ozone Substation and the 480 V low voltage outdoor yard and interior switchgear.
- Assisted in solving the sheared injector problem and leaks in the Botany Pump Station on January 24th and the lessons learned review on February 2nd.

Engineering:

- Progress continues to be made to advance the reservoir storage projects:
 - Levine Tanks Project PVWC is working with Passaic County to finalize Planning Board approval. Additionally, permit applications have also been submitted to the NJDEP and are waiting for approval. Construction is anticipated to be bid in late Spring/early Summer.
 - New Street Tanks Project investigatory borings were taken at various locations at New Street to assist in design of the planned storage tanks.
 - Storage Evaluation Study PVWC continues to work with Arcadis on extensive modeling to determine the optimum PVWC storage required while considering impacts from reservoir construction, potential transmission main failures and plant outages.

Customer Service:

- Customer service representatives have begun to periodically tour PVWC worksites to understand what is being done in the field to assist in communicating with customers on various programs.
- Developing a program for in-person appointments for PVWC customers to assist on troubleshooting issues, discussing payment plans and other subsidies that may be available.

Purification:

- Completed the annual clean outs of all the ozone contactors preparing for summer months.
- NJ DEP completed the CPE training at our facility Area wide optimization program (AWOP) identified areas where process improvements could be considered.
- All LFWTP / Remotes treatment & chemical disinfection regulatory requirements were met in January 2023.

Laboratory:

- Elected 2 Young Professionals (YPs) from the lab to represent PVWC at the upcoming AWWA-WEF YP Summit in Sacramento in March.
- Collaborated with Purification on developing a joint SOP for maintaining online analyzers and sensors throughout the filter plant and remote sites to increase cooperation and accountability.

Purchasing:

- Initiated development of SOPs and workflows of the procurement process for all contracts.
- Worked with IT to implement corrections to our Naviline Operating System (HTE) and add/delete Users. Identified Employees from Each Department who will be responsible to work on Naviline to enter requisitions and field purchase orders, as well as assigned each Department Head the responsibility of approving each requisition and field purchase order for their department.

Information Technology:

- First Quarter Standard Operating Procedures list being compiled for review.
- Pending presentation for Executive Director approval of migration to AT&T first net; large savings for PVWC.
- Pending presentation for Executive Director approval of Document Handling solution vendor.

2) Organizational Highlights – Succession Planning

- Finalizing the table of organization for PVWC and each Department to be included as part of the final strategic plan. The draft strategic plan was distributed last month without the table of organization.
- A virtual Town Hall meeting was held company-wide Thursday, January 26th to discuss and present the organizational vision for PVWC. I will be meeting with each Department as part of the regular group meetings to discuss the strategic plan and next steps.
- Performance evaluations were sent to each of the Department Heads to be completed on a quarterly basis. We are targeting rolling out performance evaluations for additional staff during the second quarter of 2023.

Lead Service Line Replacement Status:


The contract with Pacific Construction (Contract 22-B-8) started in July 2022 and the contract with CDM-Smith for CM and service line inspections began in the Spring. The overall program is estimated at \$36M and we have received 77% principal forgiveness (\$27M) from the NJ I-Bank. Work has begun on replacement of lead line in all cities with a summary listed below as of February 10, 2023.

4) Delinquent Accounts

As of January 30, 2023, PVWC ceased shut-offs due to the cold weather. We will begin shut-offs again this March however . We are currently discussing calling customers who have delinquent accounts and asking them for payment and/or offering them a payment plan. We continue to work with the Low Income Household Water Assistance Program and the NJ Winter Termination Program. The NJ Board of Public Utilities (BPU) maintains a written policy know as the Winter Termination Program (WTP) by which regulated electric or gas utility companies cannot discontinue service to certain households through March 15, 2023.

We began shutoffs of non-residential accounts on 8/22/22. Through 9/2/22 we collected \$132,600 from delinquent accounts either through full payment or agreement to payment plans. We continued shutoffs through the month of December but needed to pause due to the cold weather and the holidays. On January 11, 2023, we resumed residential shutoffs which were discontinued January 30th due to cold weather. Below is the trend of the delinquent account balances since October 2022 with an overlay of the residential shutoff period.

 - c. Press event held with Paterson and the newly formed Financial Empowerment Center (FEC) to highlight PVWC no-interest payment plans, LIHWAP subsidies and Paterson FEC resources for customers.
- c) Extensive news coverage by NBC news, ABC news, News 12, NJN Spotlight and WPIX regarding the critical number of PVWC delinquent accounts and balances, the need for PVWC to reinitiate shutoffs and State aid available.
