April 26, 2023

Board Meeting

1) Operational Highlights

<u>Project Highlight</u>: On Thursday, 4/13/23, PVWC received a call from the Belleville Police Department to inform PVWC of a leak that surfaced on the exit ramp off of Route 21 North (Exit 6) in Belleville (Kearny Multiples). The ramp was closed on Monday, 4/17/23 to excavate and evaluate the leak. After assessing the leak, PVWC reopened the ramp on Wednesday, 4/19/23. PVWC's engineering team determined that the ramp did not need to be closed at this stage of the repair process. PVWC will keep its customers informed as we work with local and state authorities on permanent repairs.

Laboratory and Water Quality

- Jory Bell and Ariel Williams attended the AWWA/WEF Young Professionals Summit.
- Interviews have been initiated for Sample Collector.
- Met with Hazen and Sawyer, and Raftelis for follow-ups about water quality/laboratory dashboards to get labgenerated information to the rest of PVWC stakeholders.

Organizational Development and Human Resources

- Fully transitioned all PVWC staff to Paylocity to track time & labor.
- Deployed the self-service portal on 4/2/23

Environmental Health & Safety

- Coagulant Ferric Sulfate Tank #4 required 5-year testing/inspection. Tank required repairs after initial inspection was conducted. Repairs were made, EHS Dept. coordinating re-inspection and finalization of payments to contractors for this work. Final inspection scheduled for April 25, 2023. Coagulant Tank #5 due in September, 2023.

Pumping and Power

- PVWC's contractor, Siemens, has started the second round of the inspection, testing, calibration, and maintenance of the electrical systems at the Little Falls site. Equipment tested this month includes work in the Filter Building Substation including the motor control centers and the switchgear and motor starters for the Backwash Pumps and the Wash Water Transfer Pumps. This work is ongoing and has required several hydraulic outages of the Filter Plant.
- Assisted in the planning for the demonstration testing and the performance testing of the new emergency generators. The demonstration testing is currently slated to start on April 25, 2023.



Distribution:

• Staff held hydrant training with the owner city fire departments on March 30, 2023.

<u>Finance</u>

- FEMA reimbursement for Hurricane Ida was received in the amount of \$2,369,843.16.
- Successfully went through an interview process for the Senior Accountant role.

Customer Service

- Finalizing logistics for in-person customer appointments which should be in place by 5/1/23.
- Exploring how to move forward with video chats in collaboration with the IT Department to better communicate with our customers.
- Training with Mark Romain to educate customer service staff on the different meter types which will assist in troubleshooting potential leaks with customers.
- Continuing to identify educational opportunities for customer service representatives to visit job sites to better understand the nature and complexities of the work performed. This will assist with customer communications.

Purification

- Completed preventative maintenance activities ahead of the peak flow demand period during the summer months: EQ basins, 4 Ozone Contactors, 4 Actiflo Trains, 4 TSB, 2 Thickeners.
- Treatment Plant production 45-50mgd Ready for summer draft (75mgd).
- Accommodated Electrical shutdowns (Startup / Shutdowns of Treatment Plant).
- Remotes Systems ready for summer draft.
- Geese Control started for the Plant and reservoirs.

Purchasing

•

- All forms of procurement are now originating with the Buyer, who is creating specifications, bid packages and distributing same to potential bidders.
- HTE access has continued to be granted to departments who did not previously have that access and training has now commenced so that each department will be responsible for entry and maintenance of their purchases and spending.
- Monthly meetings have been instituted with all departments to ensure that all procurement needs are being met so that we can project are needs in advance so that we are proactive rather than reactive. This will ensure that we will be able to determine the best way to procure goods and services at the best prices.

Information Technology

- Starting to formally discuss PVWC's GIS roadmap.
- Continuing end-user CMMS training ahead of full system deployment.
- Training will be available soon for Microsoft productivity suite and other applications.

Communications & Intergovernmental Coordination

- Communications Department published six (6) press releases since the March 2023 board meeting:

In March, we highlighted Joe Aldighieri for being named President of the NJ Section of the AWWA, as well Alex Wells for receiving the NJ Section 2023 Dedication Award.

2) Organizational Highlights – Succession Planning

- Q1 2023 performance evaluations for Department Heads have been scheduled and will be completed by April 28th.
- Q1 2023 performance evaluations will roll out to the direct reports of the Department Heads.
- Continuing to work on PVWC's Strategic Plan and finalizing organizational charts for each Department to support continued staffing needs.
- Each Department Head has instituted regular weekly/bi-weekly staff meetings and the Executive Director has begun to attend on a rotating basis to discuss any key issues and organizational strategies.

3) Regulatory Issues

Lead Service Line Replacement Status:

The contract with Pacific Construction (Contract 22-B-8) started in July 2022 and the contract with CDM-Smith for CM and service line inspections began in the Spring. The overall program is estimated at \$36M and we have received 77% principal forgiveness (\$27M) from the NJ I-Bank. Work has begun on replacement of lead line in all cities with a summary listed on the next page.

Lead and Copper


NJDEP published new rules for lead and copper that go into effect in 2024. These rules impact sampling methodologies and public notification policies that require optimizing and modifying internal PVWC business processes and resources. We have established an internal working group comprised of Executive, Laboratory, Engineering, Distribution, Communications, and Purification staff to develop workflows, identify needed resources and prepare a plan for compliance that will be in place when the new rules take effect. We continue to meet on a monthly basis.

4) Delinquent Accounts

As of January 30, 2023, PVWC ceased shut-offs due to the cold weather. We continue to work with the Low Income Household Water Assistance Program and the NJ Winter Termination Program. The NJ Board of Public Utilities (BPU) maintained a written policy known as the Winter Termination Program (WTP) by which regulated electric or gas utility companies could not discontinue service to certain household which ended on March 15, 2023. We resumed shut offs on April 4, 2023.
