EDUCATION: Graduation from an accredited college or university with a Bachelor's degree in one of the biological sciences or chemistry, including or supplemented by three (3) semester hour credits in bacteriology. Please upload a copy of your transcript with your application. Failure to do so will result in ineligibility.

Foreign transcripts must be evaluated by a recognized evaluation service. Please upload a copy of your evaluation with your application. Failure to do so will result in ineligibility.

EXPERIENCE: Five (5) years of laboratory experience in chemical and/or bacteriological testing and analysis.

LICENSE: Appointees will be required to possess a driver's license valid in NJ only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.

The responsibility for ensuring that employees possess the required motor vehicle license, commensurate with the class and type of vehicles they operate, rests with the Appointing Authority.

4. If an employment list results from this announcement, it may be certified to fill full-time and part-time positions.
