
Services: On August 8, 2025, a main break occurred in PVWC's system in the area of Hinchcliffe Stadium in Paterson, New Jersey. The main break caused a complete water outage for approximately 46,407 residents and boil water alert for approximately 85,112 residents in the City of Paterson, Borough of Prospect Park and North Haledon and the Town of Haledon.

Under the Local Public Contracts Law N.J.S.A. 40A:11-6 et seq. and N.J.A.C. 5:34-6.1 permits emergency procurement measures in emergency situations as set forth in in the LCPL and the Administrative Code.

A main break of this magnitude constituted an emergency as defined by N.J.S.A. 40A:11-6 et seq. and N.J.A.C. 5:34-6.1; in order to address the immediate health concerns of its ratepayers and the residents of the affected areas that impacted the public health, safety, or welfare, the PVWC procured emergency services. The services procured related to providing potable water as follows:
