Subject: Construction Management Software Evaluation

Passaic Valley Water Commission (PVWC) is in the process of evaluating construction management (CM) software programs to purchase for their programmatic use. PVWC asked HDR to provide CM software recommendations based on their experience. The purpose of this memo is for HDR to provide a quick overview of three programs that they have working knowledge of.

- Trimble e-Builder is used by NYCDEP Bureau of Design & Construction (BEDC) as
  well as other large utilities. We know from experience that e-Builder is ok once you get
  used to it, but the learning curve is a bit steep. Other utilities who are beginning very
  large capital programs choose to adopt eBuilder as in their case, the e-Builder
  investment (cost and effort) is worth it given the scale of their programs.
  - Trimble also offers a program called Viewpoint. I don't have experience with this project, but I am wondering if it is a more affordable option than e-Builder. <a href="https://www.viewpoint.com/">https://www.viewpoint.com/</a>
- Procore is preferred and used by contractors; however, it is reported to be pricey. We have experience using Procore for submittals tracking for another North Jersey Drinking Water Client. Online quotes and demos can be obtained online:

HDR has determined that ConstructX is not needed for the services that we typically provide during construction. Newforma costs roughly \$250 per year per user. There would be additional software costs for ProjectWise, Bluebeam, etc. to the extent you need those platforms too. Attached to this memo is a very brief Newforma overview video – you'll see how we use



Newforma along with related software, e.g., ProjectWise (file management and archiving) and Bluebeam (pdf editing individually and live with groups). External users can access the Newforma interface through a web browser which is free to them.

We believe that Newforma would allow PVWC to balance the software investment with the effort it would take to begin using it. ## **Client Request**

Passaic Valley Water Commission (PVWC) is transitioning from Invoice Cloud to Paymentus and implementing the Paymentus Customer engagement Portal to support payments via online, IVR and Cash Register. As part of this transition, PVWC will replace the Infinity Link V3 SSO from Invoice Cloud and disable Infinity Mobile. For this reason, PVWC is requesting a statement of work from Advanced Utility Systems (Advanced) to assist with their Paymentus integration.

## **Proposed Solution**

The services to be provided under this SOW are as follows:

- Advanced will share necessary details of existing Test and Prod SOAP API with Paymentus to establish communication between CIS and Paymentus.
- Paymentus will use SOAP API call to obtain payment history.

#### • IVR and Online Payments:

- o IVR Payments will be taken from Paymentus IVR.
- Advanced will assist with setting up additional payment methods and transaction codes in CIS Test and Production to be able to receive and show payments posted by Paymentus online payment methods.
- Advanced will set up the required control forms to allow PVWC to pick up these pending payments and update them through a transaction batch in CIS.
- Advanced will assist in setting up a scheduler task to pick up these pending payments (Note: Scheduler must already be working on Test and Production systems)

#### Autopay:

- o Advanced will provide a list to PVWC of all existing autopay accounts:
  - One after SOW is signed and this project is initiated.

- o CIS will obtain and store a token from Paymentus for each customer account.
- Passaic CSR will run the autopay pickup process to generate transaction batches and authorize payments

#### · Cash Register:

 Advanced will enable CIS cash register functionality to authorize payments through Paymentus.

#### CIF File:

- o Advanced will create a CIF export interface to provide customer data to Paymentus.
- Advanced will collaborate with Paymentus to ensure the CIF file meets their specifications.
- o The file will be saved at the location specified by PVWC.

- Tank 3 is volume is decreasing due to sludge build up

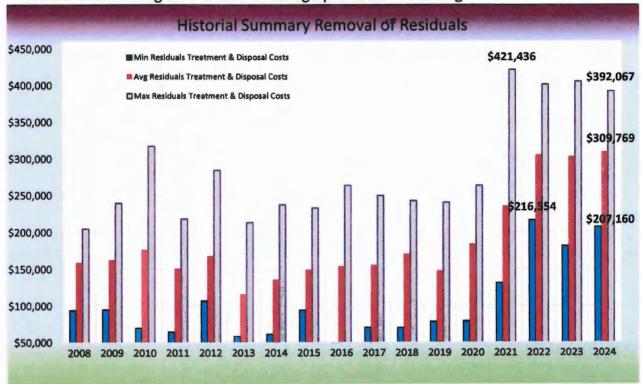
The original 3-year contract was underestimated by \$1,800,000 and a new agreement was issued in Sept 2024 (resolution # 24-106).

Unfortunately, due to circumstances out of our control such as the drought conditions, weather, issues within the treatment system and summer months (PVWC peak flow) add to the increase of our sludge production which increases the amount of sludge hauled to PVSC. This pushes us beyond what we forecasted for the first change order.

WHEREAS, the Passaic Valley Water Commission (PVWC) is the fee owner of the property located at Mary Ellen Kramer Park ("Property"), Block 801 Lot 3 in the City of Paterson("City"); and

WHEREAS, the Property is currently improved with two structures that are in use by the PVWC for water utility functions; and

WHEREAS, the unimproved portions of the Property are currently utilized for recreational use by the public and features the entrance to the Park; and

WHEREAS, the Park is determined to be a brownfield site according to environmental standards set by the New Jersey Department of Environmental Protection (NJDEP), and is included in the NJDEP Brownfield Development Area (BDA) Program within the Paterson Great Falls Tract; and

WHEREAS, the City and the PVWC have entered into an agreement that stipulates the City is able to utilize the unimproved portions of the Property for recreational purposes related to the Park; and

WHEREAS, the requirements of the NJDEP Site Remediation Program regarding brownfields require the PVWC to assign a Licensed Site Remediation Professional (LSRP) on its behalf to oversee environmental remediation of the Park; and

WHEREAS, the PVWC has agreed to utilize the City's environmental consultant, EWMA, to complete the remediation of contaminated materials, including soils from the Property without subrogating the rights and responsibilities of the PVWC as the fee owner of the site; and

WHEREAS, the City has agreed to secure funding for any environmental testing and remediation required at the unimproved portions of Property without subrogating the rights and responsibilities of the PVWC as the fee owner of the site; and

WHEREAS, the NJDEP has grant funds available for municipalities through the Hazardous Discharge Site Remediation Fund (HDSRF) Program for the purpose of funding Remedial Action (RA) environmental activities with the purpose of designating land for recreation and conservation use in perpetuity; and

WHEREAS, the City of Paterson is a qualified municipality to apply for funding on behalf of the PVWC from the HDSRF to perform the RA environmental activities on the subject Property; and

WHEREAS, there exists a contract between the City and EWMA for the preparation of a 75% Matching Recreation and Conservation HDSRF grant application and the execution of work that is prescribed in the grant application and paid for through funding awarded to the City and the PVWC's 25% matching funds; and

WHEREAS, EWMA will prepare, and the City will submit, an application to the NJDEP on behalf of the PVWC, for grant funds available to municipalities through the HDSRF Program for funding the RA environmental activities for the purpose of recreation and conservation of the Property in perpetuity; and

WHEREAS, EWMA will be assigned as the LSRP for Lot 3 of the Park on behalf of the PVWC to conduct oversight of environmental remediation activities in accordance with all applicable State and Federal laws; and

WHEREAS, in accordance with the contract between EWMA and the City, HDSRF grant funding awarded for the administration and testing associated with the RA activities shall be issued in the form of a Purchase Order to EWMA and administered through the City; and

WHEREAS, in accordance with the contract between EWMA and the City, the 25% Match for the HDSRF grant funding awarded for the administration of RA activities for the purpose of recreation and conservation shall be issued in the form of a Purchase Order to EWMA through the City.

WHEREAS, it is recommended that PVWC agrees to reimburse the City of Paterson for our portion of matching funding in the amount of \$9,630.00, as outlined in a copy of a memorandum dated June 23, 2025 from the Engineering Department, which is attached hereto as EXHIBIT A; and

WHEREAS, PVWC's Chief Financial Officer has certified, with respect hereto, that funds are currently available for said purpose and a copy of the said certification is attached hereto and made a part hereof as **EXHIBIT B**; and

In the event that funding is approved pursuant to a grant issued in favor of the City of Paterson, EWMA shall be authorized and directed to implement remedial actions for the above-described parcel in accordance with a contract to be approved by the City and the NJDEP, but only to the extent that NJDEP grant funds are available for payment for the aforesaid services; and
- 4. The acceptance of a grant issued in favor of the City of Paterson does not transfer the PVWC's responsibility for long-term monitoring and maintenance of the environmental cap that will be required by state law and NJDEP regulations following issuance of a Remedial Action Permit for the property; and

WHEREAS, Public Service Electric and Gas Company ("PSE&G") is in the process of upgrading its existing electrical facilities ("Facility Upgrades") in order to provide safe and reliable service to the public; and

WHEREAS, plans to conduct the following pre-construction site analysis activities: Property Boundary Survey, Property Appraisal, Phase I Environmental Assessment/Preliminary Assessment, Phase II Environmental Assessment/Site Investigation, Geo-tech Borings (soft digging will be performed utilizing a vacuum extractor), Site Assessment and Wetland Delineation ("the Work"); and

WHEREAS, the proposed Facility Upgrades will require ingress and egress to and from Property to the north of the Little Falls Water Treatment Plant ("LFWTP") adjacent to Riverview Drive in Totowa, Passaic County, New Jersey, owned by Passaic Valley Water Commission ("PVWC") in order to conduct the following pre-construction site analysis activities: Property Boundary Survey, Property Appraisal, Phase I Environmental Assessment/Preliminary Assessment, Phase II Environmental Assessment/Site Investigation, Geo-tech Borings (soft digging will be performed utilizing a vacuum extractor), Site Assessment and Wetland Delineation ("the Work"); and

WHEREAS, PSE&G shall not have authorization to access other areas of PVWC's properties not defined under this agreement, in particular, the LFWTP property; and

WHEREAS, PSE&G requests from PVWC the revocable right of entry upon and across the Property, as shown on the aerial map attached hereto and made a part hereof as Exhibit A, for PSE&G, its employees, contractors, subcontractors, agents and assigns, for the purpose of conducting the Work; and

WHEREAS, Right of Entry will commence the week of June 30, 2025, and will terminate upon the completion of the Work and restoration of the Property to the condition it was in prior to the commencement of the Work with Work to be performed intermittently over the course of approximately 6 months; and

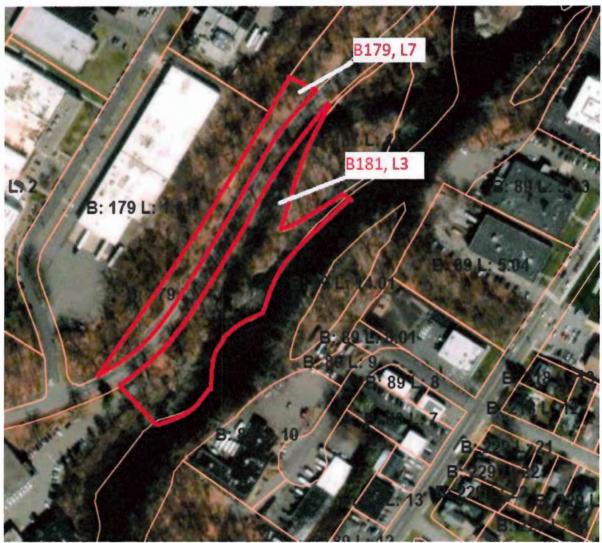

#### COOPERATIVE PRICING AGREEMENT

This agreement made and entered into this \_\_\_\_\_\_day of \_\_\_\_\_\_\_, 20\_\_\_\_\_\_, by and between the Board of Directors of Hunterdon County Educational Services Commission, referred to as the "Lead Agency" and various governing boards, authorities, commissions and other governmental contracting units within the State of New Jersey.

#### WITNESSETH

WHEREAS, the Lead Agency is conducting a voluntary Cooperative Pricing System with boards of education, municipalities, and other types of public bodies located within the State of New Jersey, utilizing the Lead Agency's administrative purchasing services and facilities in order to effect substantial economies in the purchase of work, materials and supplies; and

WHEREAS, the Cooperative Pricing System is authorized by N.J.S.A. 40A: 11-11 and has been approved by the Division of Local Government Services in the Department of Community Affairs pursuant to N.J.A.C. 5:34-7.1 et seq., and

WHEREAS, all the parties hereto shall approve this Agreement by Ordinance or Resolution, as appropriate, in accordance with the aforesaid statue; and

NOW, THEREFORE, it is mutually agreed as follows:

The work, materials or supplies to be priced cooperatively may include fuels, office supplies, paper products, instructional materials and equipment, vehicles, modulars and such other items and services as two or more participating contracting units in the system agree can be purchased on a cooperative basis.

- Upon approval of the Cooperative Pricing System and during each January thereafter, the Lead Agency shall publish a legal ad in such format as required by the State Division of Local Government Services in a newspaper normally used for such purpose by it, to include such information required by N.J.A.C. 5:34-7.9. as may be amended from time to time, including:
  - a. The name of the participating contracting unit, and
  - b. The name of the Lead Agency soliciting competitive bids or informal quotations, and
  - c. The address and telephone number of Lead Agency, and
  - d. The State Identification Code for the Cooperative Pricing System, and
  - e. The expiration date of the Cooperative Pricing Agreement.
- 3) Each of the participating contracting units shall indicate, in writing to the Lead Agency, the items to be purchased by the contracting unit, the approximate quantities desired, the location for delivery and other such requirements necessary for the Lead Agency to prepare specifications as provided by law. Although the Lead Agency endeavors to serve the needs of all registered members of the Cooperative Pricing System, the Lead Agency may not be able to prepare specifications and/or solicit bids for all projects and makes no such guarantee.
- 4) The specifications shall be prepared and approved by the Lead Agency and filed as required by law, and no changes shall thereafter be made except as permitted by law. Nothing herein shall be deemed to prevent changes in specifications for subsequent purchases.
- 5) A single advertisement for bids/proposals or the solicitation of informal quotations for the work, materials or supplies to be purchased shall be presented by the Lead Agency on behalf of all registered members desiring to purchase any item in the Cooperative Pricing System. All advertisements and solicitations shall be made in compliance with the Public School Contracts Law.
- The Lead Agency shall receive bids or quotations on behalf of all participating contracting units. The Lead Agency shall review said bids and, on behalf of all registered members, either reject all bids or award a contract in compliance with the Public School Contract Law and the specifications. This award shall result in the Lead Agency entering into a master contract with the successful bidder(s) providing for two categories of purchases:
  - a. The quantities ordered for the Lead Agency's own needs, and
  - b. The estimated aggregate quantities to be ordered by other participating contracting units by separate contract, subject to the

specifications and prices set forth in the Lead Agency's overall (master) contract.

The Lead Agency shall enter into a formal written contract(s) directly with the successful bidder(s) when required by law and, only after the Lead Agency has certified the funds available only for its own needs.

Each registered member shall: (1) certify that it has the funds available necessary for its own order(s) from the Cooperative Pricing System; (2) enter into a formal written contract directly with the successful bidder(s) when required by law and the project specifications; (3) issue purchase orders in its own name directly to the successful bidder(s) against said contract; (4) accept its own deliveries; (5) be invoiced by and receive statements from the successful bidder(s) and (6) be responsible for any tax liability. No registered member shall be responsible for payment for any items ordered or for performance generally, by or to any other registered member. Each registered member shall accordingly be liable only for its own performance and for items ordered and received by it.

The provisions of this paragraph shall be quoted or referred to and sufficiently described in all advertisements for bids by the Lead Agency so that each bidder shall be on notice as to the respective responsibilities and liabilities of the registered members.

- 7) The Lead Agency reserves the right to exclude any item or commodity from within said system if, in its opinion, the pooling of purchasing requirements or needs of the participating contracting units is either not beneficial or not workable as to the Lead Agency or the registered members..
- The Lead Agency shall appropriate sufficient funds to enable it to perform the administrative responsibilities assumed pursuant to this Agreement. It is understood that all fees for each participating contracting unit are paid to the Lead Agency by the successful bidder(s) with the exception of HCESC in-house order preparation (4%) and fuel participation. This amount shall be paid forty-five (45) days from the receipt of billing from the Lead Agency.
- This agreement shall become effective upon approval of the Director of the Division of Local Government Services and shall continue in effect for a period of five (5) years pursuant to N.J.A.C. 5:34-7.5(f), or until a party to this Agreement shall give written notice of its intention to terminate its participation in the Cooperative Pricing System..
- 10) All records or documents maintained or utilized pursuant to terms of this Agreement shall be identified by the code number assigned by the Director, Division of Local Government Services and such other numbers

#### **Expenses**

If expenses are incurred by Advanced to provide services outlined in this statement of work, Advanced staff will be using a meal per diem of \$70 per weekday and \$125 per weekend day or holiday which will be billed to the Client. The meal per diem will not be required to submit receipts. All other expenses will continue to be billed on actual-basis (i.e. airfare, hotel, car rental, fuel, mileage, travel time, etc.) and will be required to submit receipts.

#### **Escalation Process**

PVWC has implemented its Customer Information System (CIS) through Advanced Utility Systems (AUS) and seeks to integrate CIS Infinity with GIS to enhance spatial visualization and utility management. The integration will leverage embedded GIS functionality in CIS Infinity, enabling users to view ArcGIS web maps within the AccountView screen and access both GIS layers and CIS account data. Users will be able to select multiple accounts on the map to initiate actions such as generating letters, tasks, service orders, and dialing lists. Utilizing GIS REST APIs, the integration will support bidirectional synchronization, automatically posting new accounts or locations from CIS to GIS with all required PVWC fields, ensuring up-to-date spatial data for improved operations and decision-making.

The total cost for this work will not exceed \$43,525.00 per the quotation that was received by AUS. Funding has been set aside and is available under the Engineering Department's 2025 Operating Budget under the "Maintenance and Licensing Agreements" category and the project will take about 6 months to be completed.
